#### FIRST WEEK HIGHLIGHTS

## **MINIMUM WAGE**

**SB 115**, by Sen. Bob Ballinger and Rep. Frances Cavenaugh, would create an exemption to the Minimum Wage Act for employers with fewer than 50 employees, employers that are schools or institutions of higher education, and 501(C)(3) nonprofits.

We have a group of members and attorneys working on this issue. We are in contact with the sponsors of SB 115 and other legislators about this issue. We will have some suggestions on this issue soon.

We have concerns about how the minimum wage increase will impact workers, small businesses and our economy. Our President & CEO, Randy Zook, published an article in *Arkansas Money & Politics* earlier this month titled *The False Promise of Minimum Wage*. #### **BILL FILING DEADLINE ELIMINATED**

By a vote of 87 to 8, the House passed **HR 1001**, which sets the House Rules for the 92<sup>nd</sup> General Assembly. **HR 1001** contains language that strikes the historic language requiring all bills to be filed on or before the 55th session day.

**SCR 1** is language for the House and Senate's Joint Rules for the 92<sup>nd</sup> General Assembly. This Resolution also contains the provision to strike the bill filing deadline. **SCR 1** has been given a Do Pass recommendation by the Senate Rules Committee and is on Tuesday's Senate Calendar.

We view elimination of the bill filling deadline as a very positive change. It will eliminate the filing of 400, 500 or more bills on the deadline date. A large percentage of the bills typically filed on the deadline date are "shell"

bills. Shell bills contain no language but can be amended later. Keeping up with the amendments amid hundreds of new bills in the latter third of a Session is extremely difficult. We do not believe elimination of the bill deadline will extend the Session. Leadership can control when Committees will stop hearing new bills.

# **COVENANTS NOT TO COMPETE**

**HB 1068**, by Rep. Brian Evans and Sen. Ricky Hill, seeks to repeal the ability to enforce covenant not to compete agreements. Uncodified language says the repeal does not affect the ability of an employer to protect trade secrets under the Trade Secrets Act. We have been in contact with the sponsors and will be meeting with them soon. Repealing the existing statute on these covenants will not eliminate their use. Instead, legal control would return to common law. We believe modifications to the existing statute is the best approach and will work with human resource attorneys and the sponsors to develop an amendment to the bill.

#### **MEDICAL MARIJUANA**

**HB 1150** by Rep. Doug House is on Tuesday's House Calendar to adopt an amendment adding Sen. Bob Ballinger as a sponsor. This bill seeks to expand the list of qualifying medical conditions to use medical marijuana.

The original law authorized these medical conditions for medical marijuana use: Cancer, glaucoma, positive status for human immunodeficiency virus/acquired immune deficiency syndrome, hepatitis C, amyotrophic lateral sclerosis, Tourette's syndrome, Crohn's disease, ulcerative colitis, post-traumatic stress disorder, severe arthritis, fibromyalgia, and Alzheimer's disease.

HB 1150 seeks to remove glaucoma and add the following medical conditions to be eligible for medical marijuana use: adiposis dolorosa or Dercum's Disease, anorexia, Arnold-Chiari malformation, asthma, attention deficit disorder, attention deficit hyperactivity disorder, autism, bipolar disorder, bulimia, causalgia, chronic inflammatory demyelinating polyneuropathy, chronic insomnia, chronic obstructive pulmonary disease, complex regional pain syndrome Type I and Type II, dystonia, emphysema, fibrous dysplasia, general anxiety disorder, hydrocephalus, hydromyelia, interstitial cystitis, lupus, migraine, myasthenia gravis, myoclonus, nail-patella syndrome, neurofibromatosis, Parkinson's Disease, posterior lateral sclerosis, post-concussion syndrome, reflex sympathetic dystrophy, residual limb and phantom pain, restless leg syndrome, Sjogren's syndrome, spinocerebellar ataxia, spinal cord injury or disease including without limitation arachnoiditis, syringomyelia, Tarlov cysts, traumatic brain injury, or the treatment of these conditions.

#### STATE CHAMBER/AIA TRACKED BILLS
