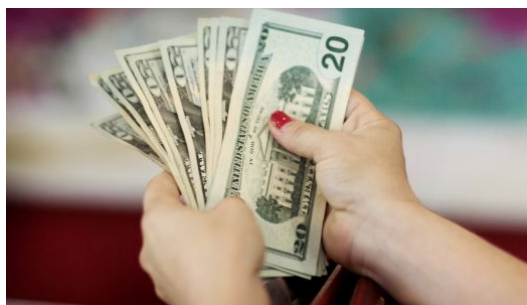

Global shares have risen amid optimism over trade talks between the U.S. and China and are headed for their best quarterly performance since 2012.

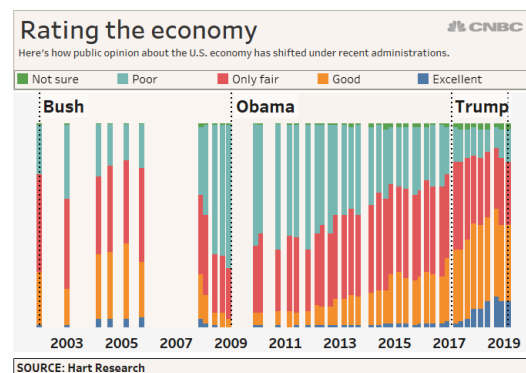

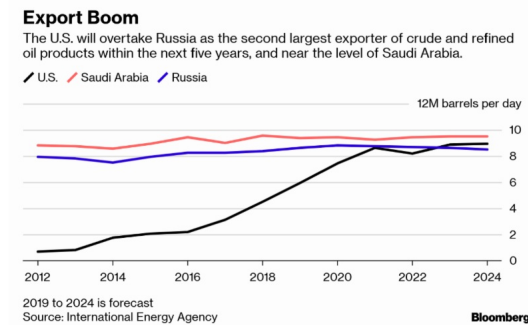
