TODAY AT THE CAPITOL

The House and Senate will convene at 1 p.m. this afternoon with only one bill each to consider.

House Education and Health committees, and Senate Ag and City, County, Local committees will meet at 9:30 this morning. After adjournment, the House Judiciary and Transportation committees will meet as will Senate Insurance & Commerce. All have short, organizational and/or Consent (noncontroversial) agendas.
