Four committees meet this morning. The Senate convenes at 1:00 p.m., and the House convenes at 1:30 p.m.

NEW TRACKED BILLS

We added [2 bills](#) to our tracking today. One creates an income tax credit for employers who provide paid family and medical leave to their employees, and the other establishes the Arkansas Challenge Plus Scholarship Program.

BILLS WE OPPOSE

Employers - Paid Leave for Early Voting

SB 230 by Sen. Bryan King

This bill requires employers to provide eight hours of paid leave to each employee registered to vote for early voting prior to a primary election, primary runoff, and general election. It also prohibits employers from penalizing employees for using this paid leave. The State Chamber/AIA opposes this bill. (Senate State Agencies Committee)
